

Cookies Policy

Effective Date – July 1st, 2023

National Air Cargo (“NAC”) and its websites – www.gonational.com, <http://www.nationalaircargo.com> and <http://www.nationalairlines.com> use first-party and third-party cookies for analytics and site performance purposes according to this policy. First-party cookies refer to cookies that are set by our website while third-party cookies are set by other website domains and it is possible some of these cookies and the information collected are accessed by other third parties. Most third-party cookies are not necessary to navigate NAC’s websites. You have the choice to remove these cookies or to not accept them at any time and continue browsing as normal.

What are cookies and why do we use them?

Cookies are files that are downloaded to your computer or mobile device when you visit certain websites. For instance, our first-party cookies allow our websites to track which pages of our websites you visited and for how long. When collecting information about your usage of our websites, your IP address (a number assigned to your computer when you use the Internet) and your visit session information is collected. However, the cookies do not collect any personal information such as your name, address, telephone number, or email address.

Some third-party cookies from service providers such as YouTube may embed advertising or preference cookies when you view videos hosted by YouTube that are embedded on our websites.

Personal data collected and types of cookies we use

Our websites use these first-party cookies and third-party cookies for analytics and site performance purposes and to share corporate videos. Information captured through cookies is stored for a certain retention period. However, you can eliminate these cookies any time before the expiration date.

The types of cookies we use are:

	It enables the website not to show the message more than once to a user. The cookie has a one year lifespan and contains no personal information.			
OptanonConsent	This cookie is set by the cookie compliance solution from OneTrust. It stores information about the categories of cookies the site uses and whether visitors have given or withdrawn consent for the use of each category. This enables site owners to prevent cookies in each category from being set in the users browser, when consent is not given. The cookie has a normal lifespan of one year, so that returning visitors to the site will have their preferences remembered. It contains no information that can identify the site visitor.
